Beijing: China this week expressed its disappointment with the European Commission's recent decisions regarding the EU's anti-subsidy investigation into Chinese electric vehicles, stressing it will take all necessary measures to defend the interests of its businesses. On September 12, a spokesperson for the

European Commission stated that the price commitment solutions submitted by the China Chamber of Commerce for Import and Export of Machinery and Electronic Products, as well as all electric vehicle manufacturers, regarding the EU's antisubsidy case on electric vehicles, did not meet the necessary requirements. The EU intends to reject the related price commitment applications.

China finds the EU disregarded the good faith and efforts made by the Chinese EV industry by rejecting flexible solution proposals without conducting thorough consultations, per a spokes-person from the Ministry of Commerce in an online statement.

On August 20 and September 9, the EC released its final disclosure in the EV anti-subsidy case, maintaining its stance and imposing high tariffs. On August 24, within the legal time frame of the investigation, the Chinese EV industry proposed a price commitment solution, which fully took into account the EU's concerns and demonstrated maximum flexibility.

The Chinese EV industry believes that the proposed price commitment is compliant, enforceable, and all technical issues could be resolved through negotiations. It was reported that several EU member states also



According to the statement, the EC rejected the solution without a detailed evaluation, undermining the confidence of the Chinese EV industry and failing to meet the expectations of EU member state

Since the launch of consultations on the EU's EV anti-subsidy case on June 22, China and the EU have conducted more than ten rounds of intensive discussions. China has submitted a substantial amount of factual evidence, along with a flexible resolution proposal, demonstrating considerable effort, accord-

ing to the Ministry of Commerce. The spokesperson stated that while the EU claims to be willing to resolve the issue through dialogues, it has

hastily and carelessly rejected China's proposals, without ever providing any concrete counter-offers or showing any genuine intent to meet China halfway. If the consultations ultimately fail to reach a consensus, the responsibility will rest entirely with the EU. It was also stressed that the key issue now is whether the EU has the political will to resolve the problem and called on the EU to demonstrate sincerity and consider the legitimate concerns of the Chinese EV industry. China has the utmost sincerity in resolving differences through dialogue and consultations, as well as the strongest determination to safeguard the legitimate rights and interests of Chinese companies. "The country will closely watch the EU's subsequent actions and will take all necessary measures to defend the legal rights of Chinese companies," said the Ministry of Commerce.



China's investments evolve with Africa's changing development needs

In June of this year, Kenya experienced protests primarily targeting the government's proposed policy to increase taxes. When analyzing the causes, Western media largely focused on Kenya's foreign debt issue, with some even linking it to the country's debt to China.

Kenya's foreign debt amounts to \$82 billion, but only about \$8 billion is owed to China, which is less than 10 percent of the total. While this total debt is substantial for a country with a GDP per capita of just over \$2,000, for a rapidly developing country like Kenya, the question is more about how to repay the debt rather than whether it can be repaid.

In fact, the Western media's focus on China-Africa relations has consistently centered on the debt issue, as this narrative aligns with their subjective assumption of the "China threat theory." This association aims to tarnish the China-proposed Belt and Road Initiative, which has played a significant role in promoting African

development and is undergoing adjustments to further enhance the economic capacity of African countries.

Of course, Western media is also concealing an increasingly prominent issue that constrains African development: Why didn't Western colonizers leave behind an economic foundation capable of supporting continued growth in Africa, such as basic manufacturing capabilities? Even the education system left by colonizers is now limiting young people's employability, becoming increasingly disconnected from local development. I discussed this matter with some locals during my recent trip to Kenya. The issues behind the recent protests are problems Kenya's economy encounters after rapid growth, which is somewhat familiar across Africa.

The protests were mainly driven by Generation Z, which is grappling with severe unemployment. The main reason for this critical issue is the maladjustment brought about by Kenya's economic rise, accelerated urbanization and the increasing number of young people receiving basic and higher education.

The most significant change I observed during this visit was that all children could now attend school. Improved road connections have enabled many young people to seek work in cities. This change has fundamentally altered the traditional tribal structure, which has been part of their culture for hundreds of years.

However, those working in cities told me that many of these young people flocking to urban areas can only find low-end jobs. Meanwhile, many newly established small and medium-sized enterprises struggle to find suitable labor.

Kenya's future looks promising with the potential of China-Africa vocational education cooperation. The current university system, established according to Western standards, offers overly theoretical courses. Graduates often lack the practical skills needed to meet the demands of the job market, especially in manufacturing. However, the introduction of vocational training institutions could bridge this gap and significantly



enhance the country's employability.

Our African guide said that speaking Chinese has become an important employment skill as many Chinese tourists visit Kenya. Also, many Chinese businesses, including small and medium-sized enterprises, need employees who can speak Chinese. Enhancing young people's employability is crucial for Kenya's economic development and long-term debt solution. This requires policy adjustments and profound reforms, with education reform being the most important.

This is also why China's increased investment in improving the quality of the labor force in African countries, including Kenya, is a reassuring sign for the country's economic future. China's influence, far from weakening due to reduced infrastructure investment, is promoting change through more targeted training

programs, which bodes well for Kenya's labor force and economic development. As creditors, the World Bank and the West could play a greater role in talent training and cultivation. The key question is whether these Western nations will prioritize African development based on the needs of the African people or focus primarily on countering China's influence.

According to WTO statistics, global service exports grew at an average annual rate of 4.9 percent from 2013 to 2023, approximately twice the growth rate of goods exports, and the proportion made up by services trade in total trade in goods and services increased to a quarter. China is a big manufacturing country. Moving toward becoming a strong manufacturing country and expanding high-level opening-up to the outside world cannot be achieved without a strong modern service industry.

China has a high position in promoting the development of the service industry. It does not do it behind closed doors, but is instead committed to promoting the indepth cooperative development of global trade in services and service industry and making progress together with the world. Since its establishment, the CIFTIS has attracted more than 900,000 participants from 197 countries and regions, and established itself as a global brand. The much-anticipated and widely welcomed CIFTIS has refuted those who believe that the attractiveness of the Chinese market has declined. During this year's CIFTIS, hundreds of activities will be held and

more than 200 integrated innovation results will be released. Fortune Global 500 and industry leading companies such as Siemens, Google, Amazon, and GE HealthCare will actively participate in the conference, and "old friends" of CIFTIS such as Philips and Tesla have chosen to "debut" their cutting-edge innovative products at CIFTIS, which demonstrates that these companies still attach great importance to the Chinese market, and China's opening-up has brought new opportunities to foreign enterprises. The scale of service trade reached a record high for the same period, with total service imports and exports reaching 3.6 trillion yuan, an increase of 14 percent year-on-year. The level and scale of service trade are continuously improving and expanding, showing an "acceleration" of China's openness to the world. Globally popular phenomena this year, such as "China Travel" and "Black Myth: Wukong," are closely linked to the openness and progress of China's modern service industry

The measures China has taken to promote the development of its service trade are steady. The Third Plenary Session of the 20th CPC Central Committee explicitly urged the country to "innovate and upgrade trade in services"; the General Office of the State Council has unveiled a set of guidelines to promote high-quality development of trade in services with high-standard opening-up; the Ministry of Commerce rolled out national and pilot free trade zone versions of negative lists for cross-border trade in services; pilot programs to expand opening in the medical field were launched, allowing foreign-funded hospitals to be established in Beijing, Tianjin, and other regions; and the number of comprehensive pilot cities for expanding the opening-up of the service industry increased to 11, with over 1,300 pilot measures introduced across 13 sectors including



technology, telecommunications, culture, tourism, and finance. Through these measures, the world can recognize China's willingness and determination to promote development through openness and achieve mutual benefits through openness.

The 1941 photo – known as "The Roaring Lion" - was taken by Yousuf Karsh shortly after Churchill gave a wartime speech to Canada's parliament.

On Wednesday, Ottawa police said the portrait had been found in the possession of a private buyer in Genoa, Italy, who was unaware that it had been stolen.

Officials also announced the arrest of a man from Powassan, Ontario, in connection with the theft and illicit sale

The 43-year-old man, whose name is covered by a publication ban, faces several charges in Canada, including forgery, theft, trafficking and damage to property. He was arrested on 25 April, investigators say, and appeared in court in Ottawa the following day.

Newswire The photograph shows Churchill, the British war-time prime minister, on Parliament Hill moments after Karsh famously took a cigar out of Churchill's mouth "I held out an ashtray, but he would not dispose

"Both of whom were unaware that the piece was stolen," police said in their statement. The suspect was identified by tips submitted by the public, forensic analysis and by using 'open-source research", police

Later this month, Canadian investigators will travel to Rome to attend a ceremony in which the unidentified buyer will formally return the art-

"Once in Ottawa Police custody, the portrait will be ready for the last step of its journey home to the Fairmont Château Laurier, where it will once again be displayed as a notable historic portrait," police said.

Athens: Greece outlined measures to boost its lagging birthrate on Thursday, from vouchers and childcare benefits to tax breaks for new parents, although experts questioned the plan's effectiveness.

Greece has one of Europe's lowest fertility rates, a dire demographic state driven by a decade-long economic crisis, emigration and changed attitudes among the young. The

prime minister has called it a national But demography experts and even threat and a "ticking time bomb" for pensions.

It currently spends around one billion euros a year on pro-child measures. Yet it recorded its lowest ever number of births in 2022.

The measures outlined on Thursday by the family, interior, finance and health ministries include tax relief for new parents, daycare vouchers, a rise in the minimum wage from 2025, pension increases and social contribution reductions.

government officials acknowledge the long road ahead.

"It is a given that the demographic problem ... cannot simply be solved by benefits and cash incentives," deputy finance minister Thanos Petralias told journalists on Thursday. Petralias said fixing the problem also required improving the education and health systems, boosting incomes and better work-life balance conditions. Tumbling birthrates are a problem for governments across Europe, where

countries including France, Italy, Norway and Spain have spent billions of euros on pro-child measures, to little effect.

The measures are part of a broader plan aimed at reversing the downward trend of Greece's birthrate, which officials had said would be unveiled in May but has been pushed back to later this year.

The plan includes affordable housing for young people, financial incentives

for assisted reproduction, and incorporating migrants into the workforce. 'They (these measures) will have no dramatic impact on births," said Byron Kotzamanis, a leading demography expect in Greece.

"There needs to be a different policy to tackle the problem at its core," he said, adding this included giving young people incentives to remain in Greece and attracting back those who left.

Tokyo: Japan is the second-best country in the world, according to a ranking published by U.S. News & World Report with input from the Wharton School of the University of Pennsylvania.

It jumped from 6th place on the 2023 list as a post-COVID boom and reforms helped bump it up on the subindexes used to calculate the overall score. Switzerland is No. 1 in the 2024 rankings,

the United States is No. 3 and the United

Kingdom is No. 8. For the index, U.S. News rates countries based on a variety of subcategories, including openness for business, power, adventure, social purpose and cultural

Japan has experienced a postpandemic boom, with tourists pouring back in after restrictions closed the country's borders to travelers. It has also become a key target

Elizabeth Beattie wide-ranging corporate reforms and rising

Japan did well in the entrepreneurial category, which scores countries based on their connections to the rest of the world, education, innovation, skill, infrastructure development and whether they possess a robust legal framework to underpin the corporate environment.

"For countries to spread prosperity to citizens, governments must find industries where they can compete globally in the digital age. These countries are seen as innovative with educated and enterprising citizens," the publication wrote in discussing the rankings.

The Best Countries index is in its ninth year and ranks 89 nations. The data are gathered by researchers surveying around 17,000 individuals in 36 countries, including business leaders and "citizens who are nationally representative of their country." Switzerland has ranked No. 1 seven times,



while the U.S. at No. 3 is an all-time best for the country. An improved perception of business openness helped the United

In the quality of life category, Denmark, Sweden and Switzerland ranked in the top three in the 2024 survey, while Italy, France and the United States took out the top three places in the cultural influence subranking.

The results provide a snapshot of how nations are perceived on the world stage, according to U.S. News executive chairman and CEO Eric Gertler.

"The report sheds light on a country's potential for economic, political and cultural success and can serve as a strategic decision-making tool for citizens, business leaders and governments to better evaluate their countries," Gertler said.

The rankings also offer insight into attitudes on various issues. More than 80% of survey respondents in Vietnam, China and Thailand are relatively open to artificial intelligence, agreeing with the statement that it offers more benefits than threats. In the West, it was seen as more of a threat. "The Best Countries report speaks to the

value of having a strong global image as nations compete for foreign trade, tourists and socioeconomic influence," said David Reibstein, professor of marketing at the Wharton School.

"The Best Countries ranking is more than a beauty contest. Global leaders need to realize that how their countries are viewed affects their economies through tourism, foreign direct investment and foreign trade, all critical components of their GDP," Reibstein said.

Islamabad: The Marmolada glacier, the largest and most symbolic of the Dolomites, could melt completely by 2040 owing to rising average temperatures, experts have said.

Italian scientists who are monitoring glaciers and the impact of climate emergency, and who took part in a campaign launched fields – have disappeared.

Celina Ali by environmentalist group Legambiente, the international commission for the protection of the Alps (Cipra), with the scientific partnership of the Italian Glacier Committee, said on Monday the Marmolada was losing between 7 and 10cm of depth a day.

Over the past five years 70 hectares (173 acres) of its surface - equalling 98 football

Since the beginning of scientific measurements in 1888, the Marmolada glacier has withdrawn by 1,200 metres in an "irreversible coma", according to organisers of the campaign, titled Caravan of Glaciers

The effects of climate emergency are visible all across the Dolomites, which have experienced winter droughts with very little snowfall. According to experts,

> tures across the region over the summer, is causing glaciers to rapidly melt. Forni, one of Italy's largest valley glaciers, has retreated 800 metres within the past 30 years and 1.2 miles (2km) over the past century. In the summer of 1987, the guard of a shelter looking out towards Forni witnessed huge chunks of ice fall from the glacier amid days of heavy storms, eventually producing a rock avalanche that triggered the Val Pola landslide and killed 43 people. In 2022, the collapse of a glacier on the Marmolada mountain, which

this, combined with the unusually high tempera-

sent an avalanche of ice, snow and rocks down the slope, killed 11 people. Owing to the melting of the glacier, tonnes of waste of all kinds have emerged in the area, including perfectly preserved weapons, sledges, letters, diaries and the bodies of soldiers who fought in the so-called white war, the fighting in the Alps of the Lombardy region of Italy and the Dolomites in Trentino Alto-Adige during the first world war.

"The Alps are a fundamental place at the national and European level, but they are becoming increasingly fragile due to the advancing climate emergency," Vanda Bonardo, national Alpine coordinator of Legambiente and president of Cipra, said. "The glacier of Marmolada is an important example." The general director of Legambiente, Giorgio Zampetti, urged the implementation of mitigation policies, such as "an effective national adaptation plan to the climate crisis, starting from the most vulnerable areas, such as high mountains".

Sopnie Binet Paris: In the recent elections in France, the far right loomed on the precipice of power. The only thing that stopped them from winning was the mobilisation of the far left. The far right was defeated, and the centrist Emmanuel Macron lost 70 MPs. The left, meanwhile, came out on top. This victory is the fruit of the broad mobilisation of trade unions and citizens. The main French trade unions put all their strength into the battle, called for the construction of a Popular Front and, with the majority of the French trade union organisations, raised a call to protest and vote

against the extreme right. This intense mobilisation enabled the forces of the left to unite and form a front against the far right, at a time when part of the ruling class was ready to collaborate with rightwing extremists. This was a magnificent victory, which no polling institute had predicted, and which remains very fragile. To ensure that the popular upsurge does not turn into a reprieve, lessons must be learned. Voting for the far right is no longer just a protest vote, but a misguided vote of hope. To combat this, it is vital that the forces of the left unite to propose alternatives to the neoliberal policies that are fuelling social despair. The programme of France's New Popular Front break with Macronism. The violence of

neoliberal globalisation, deindustrialisation, the closure of public services and the devaluation of work whose wages no longer allow people to live all generate a powerful feeling that things were better before. The far right has seized on this and turned it into a cultural issue with its

"great replacement" theory. The far right ignores the ravages of neoliberal-

decline in living conditions. In order to protect capitalist globalisation, the far right shifts our attention away from finance and towards cultural globalisation instead.

To avoid this trap, the left must be able to put forward a credible vision that will enable us to regain control over the multinational corporations and the powers of capital.

It is no longer possible to adopt a blissful approach to free trade and globalisation. We can no longer defend free trade that leads to the dumping of wages and the destruction of the environment.

The contradictions between social and environmental issues are a breeding ground for the far right. To overcome them, it is essential to attack capitalist powers. For example, the transition of the car industry from internal combustion to electric vehicles is being used by carmakers as a tool to increase the relocation of factories away from France and towards low-income countries

in the global south. Renault and Stellantis are closing dozens of factories in France and concentrating on top-of-the-range electric vehicles, often not even produced in France, which guarantee them maximum margins. A double whammy for workers: tens of thousands of job losses and the financial impossibility of buying an electric vehicle, and therefore soon of being able to drive in large parts of the country. This risks a provoking a blacklash against electric vehicles and other climate technologies.

To win back the blue-collar vote, the left needs to make a strong case for reindustrialisation, and breaking with the great blindness of the 1990s and 2000s in favour of a factory-free economy.

model to make it environmentally sustainable. The same applies to agriculture and food. To respond to the mobilisation of farmers who are demanding to be able to make a living from their work, we need to attack the profit margins of agricultural giants instead of, as the French government has done, calling into question the environmental transition of the agricultural

A critical assessment of public services needs to be done. Austerity measures have considerably weakened the quality of care in public schools and hospitals. All those who can afford it are turning to the private sector. This pauperisation

of public services is fuelling the "tax bowl". The middle classes feel they are having to bleed to pay for public services from which they no longer benefit, while at the same time the richest pay no

Professionalised politicians are less and less representative of the realities experienced by workers. Bending to the dictates of employers, politicians give them an excessive say on pay and working conditions. We need to build a new relationship between the left and the trade unions, one that respects their independence.

All over the world, the far right comes to power through an alliance with the right and part of the business community. This is being organised by a number of billionaires such as Vincent Bolloré and Pierre-Édouard Stérin in France and Elon Musk in the United States, who are buying up press titles and social netA full 80 years after the second world war, the dykes built against fascism are falling. Macron's strategy of demonising part of the left in the same breath as attacking the extreme right has undermined our ability to respond to the far right.

By turning the far right into a party like any other, and by echoing their talking points on immigration and security, Macron and the right are trampling on the heritage of Gaullism and the French resistance.

The far right are not regular political opponents. They are openly racist, homophobic, sexist and

Racist violence by far-right groups has helped to open people's eyes to the true nature of their party. But everyone needs to put their own house in order. Voting for the far right has a racist component, and trade union organisations must step up their campaigns against racism. The trivialisation of the far right is flourishing, particularly since the attacks of 7 October. The French trade union organisations have just decided to join forces in a major campaign against racism and antisemitism in the work-place to show that these struggles are inseparable and must not suffer from any ambiguity. It's a momentum that must be replicated.
