"The two leaders expressed their resolve to strengthen the long-standing friendship between Pakistan and Denmark into a strong economic partner

"They explored ways to expedite collaboration in trade and investment through the promotion of Public-Private Partnerships," it continued. In August 2022, Pakistan and Denmark signed the Green Framework Engagement Agreement, aiming to enhance collaboration on climate change mitigation, renewable energy and sustainable development. The relations between both sides have also faced challenges in the past. In 2005, anti-Islam caricatures published in a Danish newspaper led to public protests

Recently, Denmark faced criticism from Muslim states for allowing public burnings of Islamic scripture. In December 2023, however, the Danish government enacted a law criminalizing the public desecration of religious texts, deescalating tensions and aiding in the normalization of diplomatic relations with Muslimmajority countries.?



## Why foreign companies are l-term success in

The findings of a Wednesday-released report from the American Chamber of Commerce on the state of business in southern China reveals a fascinating trend: Despite ongoing geopolitical tensions and weakened confidence in the future of China-US relations, American companies are reinvesting in China. They are expanding operations in the world's secondlargest economy and aiming for more outstanding market share.

But why is this happening? Is it just because of the size of the Chinese market? The answer is simple: While the market size is undoubtedly a factor, the real reason runs deeper.

Without the cooperation of Chinese manufacturing, some of the most iconic American industries and globally leading high-tech products would struggle to survive. Take a closer look at the rapid evolution of Chinese manufacturing in recent years, and you'll see that the US and Chinese industries have developed a unique relationship of "having complementary advantages and moving forward together," offering a promising future for both parties.

Let's start with a story that perfectly illustrates this point. US tech company Apple

Ding Gang is set to launch its highly anticipated iPhone 16e series on February 28, and China's BOE Technology Group will supply over 15 million flexible LTPS OLED displays for the lineup. This milestone marks a significant breakthrough for the Chinese company, solidifying its position as a major player in the high-end OLED display market. BOE has not only caught up with traditional giants like Samsung Display and LG Display, but in some areas, it has even surpassed them.

> However, this success didn't in 2021, BOE attempted to supply Apple with OLED screens, but only secured a small batch order due to issues with production stability and yield rates.

Nonetheless, over the years, through sheer determination and relentless effort, the Chinese display panel manufacturer finally met Apple's demanding standards and, in the process, significantly improved its own technological capabilities.

This story demonstrates why for-

eign companies can't simply walk away from China: China is the only place where cutting-edge technological requirements can be broken down into scalable manufacturing processes.

For decades, the prevailing narrative was that foreign companies couldn't leave China because of its massive market. However, the Apple-BOE story offers a new perspective: China is not just a market for foreign companies; it is come without challenges. Back their "technological survival partner." China's supply chain ecosystem covers every step of the production process, from raw material procurement to semi-finished goods processing to precision mold manufacturing. Most importantly, these processes are constantly being upgraded and integrated.

> What sets Chinese manufacturers apart is their ability to "follow orders" and their capacity to drive independent innovation through partnerships with foreign companies. Chinese manufacturers can quickly adjust their processes and respond to shifts in market demand or upgrades. Their adaptability and commitment to innovation make them reliable partners for foreign companies and this partnership can-

not be easily severed by policy or replaced by a single alternative market.

Washington has called for companies to "decouple" from China, but business leaders understand that leaving China entails more than just losing access to its market. It also means sacrificing supply chain efficiency and technological partnerships - losses that can't simply be offset by "adjusting operations."

Companies like Apple and Tesla choose China not merely for shortterm convenience, but because it fosters global industrial specialization. This is not something that can be replaced by policy or replicated elsewhere.

As China continues its push toward manufacturing upgrades, this relationship will become more substantial and inseparable. For American companies, staying in China is not just a choice - it's a necessity

US tech firms, European luxury brands, and Southeast Asian agricultural exporters, among others, all benefit from the purchasing power of Chinese consumers. The rise in Chinese residents' income is injecting new vitality into the global economy.

Moreover, China's experience can inspire other countries, demonstrating that with effort and sustainable economic development, a better life for people is achievable.



Of course, compared to developed countries, there is still a gap in the income levels of Chinese residents. What can China do in the future to narrow this gap? Reaffirming Pakistan's resolute support to the Palestinian people in their struggle for selfdetermination, Ambassador Asim Iftikhar Ahmad said that a sovereign, independent and contiguous State of Palestine based on pre-1967 borders, with Al-Quds Al-Sharif as its capital, was not just a political necessity — it is a moral imperative. "If we truly believe in the UN Charter principles, if we stand for justice, for the rule of law, for the fundamental right of all peoples to live in dignity - then we must act,"

Earlier, Ms. Kaag, the UN official in the region, urged





Sofia: Bulgaria's Interior Minister, Daniel Mitov, said this week that the country's border with Türkiye is among the bestprotected external European Union frontiers, based on the statistical data.

The Minister said that the Interior Ministry is managing quite well the increasing amounts of drugs being seized and human traffickers arrested along Bulgaria's Schengen borders, Schengen.News reports.

Mitov addressed the journalists about his department's performance since Bulgaria became a full member of the Schengen Zone on January 1, 2025.

Representative to Bulgaria Yordanka Chobanova said Bulgarian authorities have shown remarkable dedication to protecting the borders. The decision came following the approval from the European Union Ministers in order to allow Romania and Bulgaria to join Schengen from January 1, 2025.

EU member states have decided to remove checks on persons at the internal land borders with and between Bulgaria and Romania from 1 January 2025. Council of the European Union Bulgaria and Romania entered the Schengen Zone partially in March 2024, by air and sea, however, land border controls remained effective.

Among the conditions to become part of the EU Schengen Area for Bulgaria and Romania was to keep the number of irregular migrants low. However, the data from Frontex revealed that in 2024 there was a decline of 38 per cent in irregular border crossings in EU countries.

### Trump to sell 'gold card' US visas for \$5m



Washington: US President Donald Trump unveiled plans this week to sell new "gold card" residency permits for a price of \$5 million each — and said Russian oligarchs may be eligible.

Trump said sales of the new visa, a highprice version of the traditional green card. would bring in job creators and could be used to reduce the US national deficit.

"We're going to be selling a gold card. You have a green card, this is a gold card. We're going to be putting a price on that card of about \$5 million," Trump told reporters in the Oval Office.

The Republican president, who has made the deportation of millions of undocumented migrants a priority of his second term, said the new card would be a route to highly prized US citizenship.

'A lot of people are going to want to be in this country, and they'll be able to work and provide jobs and build companies," Trump said. "It'll be people with money." Sales of the cards would start in about two weeks, Trump added. "We'll be able to sell maybe a million of these cards. We have it all worked out from a legal standpoint," Trump added. The billionaire

Newswire former real estate tycoon said that all applicants for the new gold cards would be carefully vetted. But asked if wealthy Russians would also be able to apply, Trump said it was a possibility. "Possibly, I know some Russian oligarchs that are very nice people. It's possible," Trump said. "They're not as wealthy as they used to be. I think they can. I think they can afford \$5 million.'

> A number of Russian oligarchs have been hit by western sanctions since Moscow's invasion of Ukraine three years ago. Trump has caused shock in European capitals by suddenly opening negotiations with Russia to end the war, amid fears that he could be willing to sell Ukraine short. The US president told reporters that lifting sanctions on Russia was possible "at some point" but was not currently on the table. US Commerce Secretary Howard Lutnick, standing at Trump's side in the Oval Office, said of the gold cards that "we can use that money to reduce our deficit" Trump, who has branded a series of hotels and casinos in a long business career, even suggested the new cards could also be named after him. "Somebody said, 'Can we call it the Trump gold card?' I said, 'If it helps, use the name Trump,'

# £20 m allocated to support migration governance: EU delegation envoy

Islamabad: With growing concerns over irregular migration and human smuggling, experts at a high-level dialogue this week underscored the need for structured and legal migration channels so that the root cause of irregular migration might be addressed.

The dialogue on 'Safe Migration Pathways for Aspiring Pakistani Migrants' was organized by the Sustainable Development Policy Institute here. Philipp Oliver Gross, the Deputy Head of European Union Delegation, reaffirming the EU's commitment to structured migration partnerships with Pakistan, said that migration, when managed properly, benefits both migrants and host countries. Acknowledging the challenge of skills mismatch, he said while Europe has labour shortages, most Pakistani migrants do not meet the required skill levels. He further said the EU's Talent Partnership Programme aims to align Pakistani workforce training with European market demands. He said the EU has allocated

reintegration programmes. Dr Arshad Mahmood, Federal Secretary for Ministry of Overseas Pakistanis & Human Resource Development, said that while migration is a key economic driver, policies must balance economic benefits with social impact.

He emphasized that Pakistan's remittances have reached \$35 billion, yet there is a significant untapped potential to increase foreign earnings through structured migration policies.

A comprehensive National Migration Policy is under review and will soon be presented to the federal cabinet for approval, he said, adding that Key initiatives include the EU-Pakistan Talent Partnership, which is creating structured pathways for skilled workers in IT, healthcare, and construction, alongside collaborations with Germany, Finland, and Estonia for vocational training programmes in hospitality, caregiving, and technical trades. He also announced that Pakistan is developing a cloud-based digital platform to match workers with verified international employers and is offering uncollateralized migration loans through debit cards, enabling safer financial planning for legal migration

Dr Abid Qaiyum Suleri, the Executive Director of SDPIs, emphasized the need for collaboration among policymakers, civil society, and international agencies to create a migration framework that prioritizes security, economic development, and human dignity. By establishing structured legal migration channels, promoting skill development, and enhancing governance, Pakistan can maximize the benefits of labour mobility while mitigating the risks of irregular migration. Muhammad Tayyab, Director-General, Bureau of Emigration & Overseas Employment, provided a comprehensive overview of Pakistan's migration trends, highlighting the growing demand for skilled labour internationally He acknowledged that nearly 58-59% of Pakistani migrants are unskilled, leading to a significant mismatch between aspirations and global job market needs. To address this, he stressed the need for a "Skill Emergency," urging closes collaboration between the government and training institutions such as NAVTTC and TEVTA to equip Pakistani workers with global-

he said, 600 licenses of overseas employment promoters (OEPs) have been canceled, with over 30 more suspended for violations, while over 500 complaints against illegal agents have been forwarded to the Federal Investigation Agency, resulting in PKR 150 million in recoveries

eries.

Additionally, the Bureau is modernizing migration processes by digitizing recruitment channels to reduce reliance on intermediaries and ensure greater transparency in labor migration. The Bureau also highlighted that migration contributes \$32 billion annually to Pakistan's economy, with over 1 million Pakistanis migrat-

ing each year, he added.

highlighted the issue in the
backdrop of recent migrant
tragedies, including the
January 2025 sinking near
Mauritania following similar incidents in Greece and
the Mediterranean in previous years.

He said despite migration to the Gulf countries remains largely regular, but costly, irregular migration to Europe persists due to lower financial barriers, but higher

Dr. G.M. Arif, a migration and development expert, highlighted that many migrants willingly undertake dangerous journeys despite being aware of the risks. He elaborated upon the importance of enhancing oversight of migration intermediaries to prevent fraud and deception and suggested learning from successful migration models

such as the Philippines, where district-level engagement ensures better regulation.

Ms Raana Rahim, Senior Advisor at International Centre for Migration Policy Development, highlighted the critical role of awareness campaigns in ensuring safe migration decisions. She highlighted the success of Migration Resource Centers (MRCs) in Lahore, Islamabad, and Peshawar, which actively educate potential migrants about legal pathways and the risks of irregular migration routes. She said that many irregular migration routes with low education levels, often influenced by family and peers in their search for a better lifestyle.

Sajjad Mustafa Bajwa, a former senior officer at the Federal Investigation Agency, explained how smugglers exploit legal loopholes and shift transit routes, particularly via Iran, Turkey, and Libya, as stricter border controls reduce direct access to Europe.

Human smugglers, he said, exploit religious visa loopholes where migrants are sent to Iran, Iraq, or Saudi Arabia as religious pilgrims before illegally transitioning to Europe. Pakistan's crackdown on human smuggling has intensified, leading to the suspension of some FIA officials for negligence. He emphasized the need for specialized immigration courts.
