Pakistan, Denmark forge \$2 billion

Islamabad: Pakistan and Denmark this week announced a significant partnership worth \$2 billion to modernize the country's maritime infrastructure This collaboration aims to improve port operations and enhance global trade competitiveness. The announcement came during a meeting between Federal Minister for Maritime Affairs Junaid Anwar Chaudhry and Danish Ambassador Jakob Linulf.

They agreed to accelerate the implementation of a Memorandum of Understanding (MoU) signed last year, with Danish shipping giant AP Moller-Maersk leading the investment.

The discussions included plans to upgrade logistics infrastructure and incorporate green technologies in shipping. Both parties stressed the importance of using renewable energy in port operations. They also emphasized the need for workforce development and

cultural exchange to strengthen their partnership. Maersk CEO Vincent Clerc is scheduled to visit Pakistan this week to meet with the prime and other senior officials

Chaudhry highlighted efforts to adopt sustainable practices to reduce emissions at Pakistani ports. The initiative will integrate renewable energy sources like solar and wind to cut reliance on fossil fuels. Additionally, he noted that training would be provided to maritime professionals to manage eco-friendly vessels effectively. These steps aim to position Pakistan as a responsible trading partner in global markets. By adopting green shipping practices, Pakistan hopes to enhance its brand image and boost export competitiveness. The minister stated that lowering operational costs would benefit the economy in the long run. Beijing: China has nearly closed the artificial intelligence (AI) performance gap with the United States, with its leading models achieving near parity with American counterparts on key benchmarks, a Stanford University report released April 7 showed.

Top U.S. and Chinese AI models achieved near parity on these performance benchmarks by the end of 2024, Stanford's latest AI Index report found. The U.S. lead over China shrank to 0.3% on MMLU, 8.1% on MMMU, 1.6% on MATH, and 3.7% on HumanEval tests, the data showed. That contrasts sharply with U.S. advantages of 17.5%, 13.5%, 24.3%, and 31.6% respectively on the same benchmarks at the end of 2023, according to the annual analysis. These benchmarks test distinct AI capabilities. MMLU assesses broad knowledge; MMMU tests combined text and image understanding; MATH measures complex mathematical problem-solving; HumanEval evaluates code generation, CEN reported on Friday.

Notably, top-tier U.S. models have generally required significantly more training compute than their Chinese counterparts, the analysis found. Since late 2021, the compute used for the top 10 Chinese language models scaled about three times per year, slower than the five-times-peryear rate seen elsewhere since 2018, ac-



cording to Epoch AI data cited in the report.

This compute difference is reflected in estimated costs, with some prominent Chinese models like DeepSeek-V3 reportedly trained for millions of dollars, compared to figures exceeding \$100 million or even approaching \$1 billion cited for

some leading U.S. models. China leads globally in AI publications and patents filed, the report said. Chinese institutions produced 15 'notable' AI models in 2024, second only to the U.S. (40 models) and ahead of Europe (3 mod-

The report cited DeepSeek's R1 model

from China ranking among top global AI systems. Separately, the performance lead held by the best U.S. model over the best Chinese model narrowed from 9.26% in January 2024 to 1.70% by February 2025, the data indicated

This near parity was reached despite U.S. private AI investment (\$109.1 billion in

2024) significantly exceeding China's (\$9.3 billion), the Stanford report noted. Published annually by Stanford's Institute for Human-Centered Artificial Intelligence (HAI), the AI Index report is a comprehensive resource tracking global AI trends.

Zhengzhou: As spring brings longer days and milder temperatures, urban dwellers are rediscovering the joy of outdoor activities. While running and cycling remain staples of Beijing's fitness scene, a quieter yet growing trend is unfolding on the water.

Against Beijing's iconic skyline, Chaoyang Park offers a rare urban oasis where colorful kayaks and paddle boards dot the lake as people embrace water sports.

"Even complete beginners like me can pick it up quickly, and the stunning views make for such a relaxing experience. I'll definitely bring friends and family next time," said one netizen on Dianping, a popular online review platform. The rising tide of interest in water sports is driving demand for coaches, clubs and equipment, creating a host of new opportunities in this sector

"We kicked off this year's boating season in March and expect to see 200 to 300 visitors per day during the summer peak," said Cheng Helong, founder of Beijing Whalesports Club, which offers kayaking, rowing, stand-up paddle boarding and various other water activities. With four bases operating across Beijing from March to October, the club expects to host around 30,000 participants this year. "Since opening our first base in Chaoyang Park

Henan Daily in 2018, we've seen a growing enthusiasm for water sports," Cheng said. "With support from national and local sports bureaus, we've organized multiple paddle board competitions to promote aquatic activities."

Near Chaoyang Park's paddle board hub, the Liangma River has become another popular water recreation spot for locals and visitors. In 2019, Chaoyang district launched a waterfront vitalization project, transforming the river from a polluted, sediment-choked channel into a serene retreat for city dwellers.

While Beijing's water sports scene is on the rise, Shanghai, already a city deeply connected to its waterways, continues to expand its offerings. The 2024 Head of Shanghai River Regatta, for instance, transformed the bustling downtown stretch of the Suzhou Creek into a 4.2-kilometer racecourse winding past centuries-old historical landmarks such as the Garden Bridge and Shanghai Postal Museum.

The event attracted elite rowing teams from around the world, including the British and Australian national teams, as well as crews from the University of Cambridge and Oxford Brookes University.

"Racing through Shanghai's city center was an incredible experience, the winding course was challenging, and the cheering crowds made it even more exciting. I'd love to return," said

British rower Daniel after the race The event's impact extends beyond the sport itself. According to the Shanghai Sports Bureau, the 2024 Head of Shanghai River Regatta, along with the 2024 Shanghai Marathon and the 2024 Shanghai Sailing Open, generated direct economic benefits of 962 million yuan (\$134 million).


This aquatic enthusiasm has gone viral. Kayaking-related hashtags on short-video platform Douyin have amassed nearly 1.2 billion views. The trend isn't limited to megacities. Eight-year-old Wu Ze, who lives in Yongjing county, in the upper reaches of the Yellow River in Gansu province, began practicing paddle boarding last year.

"In winter, I can still practice after putting on warm clothes, and the Yellow River is just my theme park," Wu Ze said.

The boy's hard work paid off when he claimed the title in U9 group at the 2024 China stand-up paddling masters last July. Building on young enthusiasts such as Wu Ze,

China is using nationwide programs to nurture a new generation of water sports enthusiasts. Last year, over 2,000 youths from more than 20 provinces and cities joined surfing, and paddle boarding camps organized by the Water Sports Management Center of the General Administration of Sport of China. Meanwhile, 79 universities have incorporated these activities into their curricula.

These national initiatives are being complemented by regional efforts. Jiangsu province, for instance, introduced guidelines last year to develop its water sports industry. Key measures include improving public access through better facilities and specialized programs, boosting the market by integrating water sports with tourism and leisure activities and promoting sustainable growth through better safety standards and government support. According to the China Outdoor Sports Industry Development Report (2023-2024), more than one million people in China have purchased surfing and paddle boarding goods and services.





Rome: Pakistan and Italy this week an ambitious target to double their bilateral trade volume to at least \$3 billion in the coming years, according to Consul General of Italy in Karachi, Fabrizio Bielli.

Speaking at the Karachi Chamber of Commerce & Industry (KCCI), Bielli emphasized the vast economic opportunities in Karachi, describing the city as one of immense potential. "There is significant untapped potential in various sectors, including energy, agriculture, water recycling, and industrial machinery," he noted. Bielli, who took office as Consul General just two months ago, highlighted Italy's position as a global leader in producing high-quality machinery for the textile sector, along with advanced medical equipment like incubators for newborns. He expressed Italy's willingness to support Pakistan in addressing its growing healthcare infrastructure needs.

"We are in a strong position to support Pakistan in these areas," Bielli added.

The event was attended by senior

KCCI officials, including Senior Vice President Zia ul Arfeen, Vice President Faisal Khalil Ahmed, Chairman of the Diplomatic Mission & Embassies Liaison Subcommittee Ahsan Arshad Sheikh, Former President Majyd Aziz, and other members of the **KCCI** Managing Committee. Bielli expressed his keen interest in exploring Karachi's economic landscape and potential for collaboration, specifically highlighting opportunities in the pharmaceutical sector. 'We should work

towards creating joint ventures to manufacture Italian pharmaceutical products in Pakistan," he said,

Newswire stressing the need for greater cooperation between the two nations. To further these objectives. advised KCCI to develop and share a sectoral requirement report three times a year.

This report would provide valuable insights for Italian institutions and businesses, helping them better understand the opportunities available in Karachi and across Pakistan. He also encouraged KCCI members to utilize the services of the Italian Trade Promotion Section at the Con-

sulate, which focuses on boosting bilateral trade and investment, particularly for small and medium-sized enterprises.

"More than just a window, a door is open at the Italian Consulate for promoting trade and investment ties,' Bielli stated, urging both sides to work together to identify opportunities and strengthen economic and commercial relations.

Zia ul Arfeen, Senior Vice President of KCCI, highlighted the growing significance of Italy as a trading partner for Pakistan within the European Union.

"The bilateral trade volume between the two countries crossed \$1.6bn in FY24, with Pakistan's exports to Italy reaching \$1.12bn," he pointed out, noting that the balance of trade is favorable to Pakistan.

Zia also emphasized the global economic challenges posed by the recent increase in US tariffs.

He viewed this as an opportunity for Pakistan to strengthen its ties with strategic trade partners like Italy and explore new avenues for economic diplomacy.

"This is also an opportunity for Pakistan and Italy to explore ways to boost exports and enhance bilateral trade," he added.

Zia further stressed the potential benefits of adopting globally renowned Italian brands and practices, such as the circular economy, water treatment, and renewable energy, to enhance the sustainability of Pakistan's textile sector.

"By incorporating Italian engineering and design expertise, we can significantly improve the local automotive industry," he stated.

Highlighting Pakistan's strategic advantages, Zia noted the country's robust GDP of \$374bn, a population of 241.49m, and vast natural resources.

"Pakistan's coastal belt, special economic zones under the China-Pakistan Economic Corridor (CPEC) and the Special Investment Facilitation Council (SIFC) make it an attractive destination for global business and trade," he said.

He encouraged Italian companies to





CPEC and SIFC, focusing on sectors like mining, energy, agriculture, IT, and tourism. Additionally, he suggested that both

countries collaborate on publicprivate partnerships in tourism and hospitality to drive growth and attract more international visitors





Revisit Beijing Consensus' to navigate challenges

Currently, economic globalization is facing strong headwinds. The "Washington Consensus," once promoted by the US and other Western countries as the standard model for development, has not only lost its appeal among many developing nations but has also proven ineffective in addressing internal challenges within developed countries. Amid growing discussions about finding solutions that are better aligned with national realities and more responsive to domestic demands, the "Beijing Consensus" - a term that gained international attention over two decades ago - has been revisited by some observers as a possible approach to addressing today's global challenges.

In 2004, the phrase "Beijing Consensus" was coined by Joshua Cooper Ramo of the global advisory firm Kissinger Associates to describe China's economic development model as an alternative - especially for developing countries - to the "Washington Consensus." Innovation, development and self-determination are the three fundamental principles of the "Beijing Consensus." By adhering to these principles, China has effectively seized the opportunities presented by economic globalization, achieving rapid economic growth and long-term social stability. The "Beijing Consensus" encapsulates the successful experience of a late-developing nation actively engaging in globalization and achieving swift progress. The principles it outlines continue to hold unique value, especially as the process of economic globalization faces increasing challenges.

First, although economic globalization is encountering various obstacles and challenges, and the global situation remains turbulent, the overarching themes of peace and development have

Yang Xuedong not changed. Only through continuous innovation can we address the various "voids" created by power transitions and institutional stagnation; only through sustained development can we be equipped to tackle the growing "deficits" brought by increasingly complex and significant challenges

Second, new uncertainties and risks continue to emerge in the world. It is neither viable to passively wait for problems to resolve themselves, nor effective to revert to the binary thinking of the Cold War era. Only by encouraging exploration and innovation at the levels of global norms and institutions, and by allowing space for inclusive trial and error, can we find appropriate paths and workable solutions to navigate this unprecedented global transformation.

Third, as countries around the world face widespread challenges in domestic governance, it is no longer feasible to simply "leave it to the system" to self-correct the complex interplay of old and new issues. Nor should hegemonic powers be allowed to create new turmoil and division in a straightforward and domineering way, using them to mask deep-rooted structural problems. Instead, innovation and development must be integrated coherently to lay a solid foundation for easing interest fragmentation and addressing related challenges.

Fourth, the hegemonic behavior of some major powers on the international stage has become a key driver of ongoing global instability. Some may claim that this is simply the "result" of independent decision-making taken to its extreme, but the opposite is actually true. Genuine independent decision-making does not mean advancing one's own interests at the expense of others, which only deepens existing problems. Maintaining and advancing exchanges and



cooperation in various fields is the prerequisite for independent decision-making.

In today's world. China has remained committed to high-level opening-up and promoting win-win development for all countries. China will continue to uphold genuine multilateralism and work with more partners to advance an inclusive and beneficial form of economic globalization. This position offers timely insights into what the "Beijing Consensus" might contribute to the world today.

As a major developing country, China has consistently advocated for common development and shared responsibility. In an already deeply interconnected world, there is no room for building a "small yard, high fence" centered solely on self-interest. Economic and trade issues must not be arbitrarily politicized or securitized. These actions are portrayed as measures to ensure "security." However, the truth is that they run counter to basic economic principles and reflect a form of deglobalization that will only spark greater turmoil across the globe.

China has never separated domestic development from international development in a simplistic manner. Instead, it has consistently sought a positive and mutually reinforcing relationship between the two China's successful experience vividly

illustrates that economic globalization is an irreversible historical trend. Although it was initiated and long dominated by Western countries, the growing participation, both passive and proactive, of an increasing number of countries has made globalization more open and diverse.

This transformation offers late-developing countries greater opportunities and favorable conditions to independently choose their own paths to development.

President Xi Jinping met with visiting Spanish Prime Minister Pedro Sanchez in Beijing on Friday This marks Sanchez's third visit to China within three years, highlighting Madrid's emphasis to deepening China-Spain relations and representing the continuation of the friendly policies toward China from many European countries. Sources from the Spanish government revealed that Sanchez's visit was supported by the European Commission. Xi pointed out that China always sees in the EU an important pole in a multipolar world. China is a major country that explicitly supports the unity, development, and growth of the EU. President Xi further stated that China and the EU

should step up to their international responsibilities, jointly safeguard economic globalization and the international trade environment, and jointly reject unilateral and bullying actions. China and the EU

should defend not only their own legitimate rights and interests but also international fairness and justice and international rules and order. Sanchez responded positively, expressing that the EU is committed

to open and free trade, upholds

lateralism, and opposes unilateral tariff impositions. For a long time, the political land-

scape within the EU has been complex and diverse. Amid the persistent noise of so-called "de-risking" from China the mutually beneficial and win-win cooperation between China and Spain has served as an example for China-EU relations

In recent years, Spanish agricultural products have increasingly gained favor among Chinese consumers, while China's strengths in new energy technologies and manufacturing have injected new momentum into the Spanish economy. The Mobile World Congress in Barcelona

has even become a "shining showcase" of China's new quality productive forces in Europe.

People have noticed that on April 9, after the US Treasury Secretary Scott Bessent threatened Spain by saving that getting closer to China would be like 'cutting its own throat," Luis Planas, Spain's Minister of Agriculture and Fisheries, Food and Environment, countered, stating that the country intends to "not only continue having" excellent trade relations with China, but also "expanding" the relation. In the shared endeavor to fight against unfair tariff barriers and uphold multilateralism and economic globalization, China and Spain have become partners on the same path.

Sanchez's visit has pressed the "accelerator" on deepening China-EU cooperation. On April 8, China's Commerce Minister Wang Wentao and

European Commissioner for Trade and Economic Security Maros Sefcovic held a talk via video and reached a consensus that "the two sides agreed to immediately start negotiations." Foreign media reported that China and the EU have agreed to look into setting minimum prices of Chinese-made electric vehicles instead of tariffs imposed by the

Behind this breakthrough lies a deep mutual understanding that "there are no winners in a trade war " It not only helps China and the EU effectively avoid an escalation of trade tensions, preserving market space for automakers and other enterprises along the production and supply chains, but also offers a real example of how negotiation and cooperation can resolve trade disputes and mitigate conflict between nations with sincerity and mutual respect.

The EU, like China, is a staunch supporter of economic globalization and free trade. China and the EU account for over one-third of the world's total economic output, having

formed a close economic symbiotic relationship. Various signs indicate that recently, Brussels has shown a more constructive attitude toward developing relations with China. This shift is driven not only by economic interests but also by a pursuit of strategic autono-

At the 2025 China Development Forum, European companies made up about 40 percent of the total attendees. European business executives "voted with their feet" by coming to China, expressing optimism about China

and increasing their investments there. This has rendered many deliberately politicized and weaponized trade issues ineffective. The vitality of China-EU relations is also attributed to the fact that it is not an "exclusive game," but rather an "open and winwin" situation that does not target, depend on, or be constrained by any third party.

China and EU have a high degree of alignment it their shared opposition to trade protectionism and commitment to multilateralism. Their cooperation in areas such as trade, global governance, and climate change demonstrates strong resilience

The positive signals conveyed by Sanchez's visit to China call for more like-minded individuals to join in supporting multilateralism and open cooperation We look forward to a stronger resonance within Europe as well as the international community from the joint message of China and Spain, advocating

for dialogue rather than confrontation, openness

rather than closure, and rules rather than power.

## Ahmad says Pakistan deeply alarmed by Israel's attacks on sovere

Islamabad: Pakistan this week urged the United Nations Security Council (UNSC) to act "decisively" against Israeli airstrikes in Svria which were damaging civilian infrastructure and urban centers and causing civilian deaths, the country's permanent mission to the UN said on Friday. Israel took advantage of the fall of former Syrian president Bashar Assad's longstanding regime in December to expand its military presence in Syria. It now controls a 400-square-km demilitarized buffer zone, supports the Druze minority and opposes the current Syrian leadership. Israel has recently stepped up airstrikes on Syria, which it described as a warning to the newly formed government in Damascus. Israel says it is targeting military headquarters and sites containing weapons and ammunition.

"Pakistan is deeply alarmed by Israel's ongoing and escalating attacks on sovereign Syrian territory," Pakistan's Permanent Representative to the UN, Asim Iftikhar Ahmad, told the 15-member UNSC during a briefing session on Syria. "The recent airstrikes targeting multiple locations in Syria, including civilian infrastructure and urban centers, have caused civilian casualties and pose a grave threat

Celina Ali to regional and international peace and security.'

He said the world was witnessing a "deeply troubling pattern" of continued, unprovoked Israeli military aggression, repeated violations of the Disengagement Agreement, an illegal military presence in the Area of Separation, and open declarations of indefinite occupation.

"This blatant disregard for Syria's unity, sovereignty and territorial integrity must be unequivocally condemned," Ahmad said. "The [UN] Council must demand Israel's complete withdrawal from the occupied Golan Heights."

The Agreement on Disengagement between Israel and Syria, signed on May 31, 1974, maintained the existing ceasefire and called for the separation of opposing parties by a UN Peacekeeping Force.

After Assad's fall, Ahmed Al-Sharaa, who led anti-regime forces, was declared president for a transitional period in late January.

Israel said it will not tolerate an Islamist militant presence in southern Syria and has deployed troops into



Syria's border zone. However, Syria's leadership has indicated it does not intend to open a front against Israel

Ahmad said Israeli actions were under-

mining Syria's efforts for "political stabilization" and "national reconciliation," setting dangerous precedents in the region. Warning that continued Israeli escalations could ignite a wider conflict, Ahmad said diplomacy, de-escalation and reconstruc-

tion should be the world's top priorities. He also demanded the UNSC condemn Israel's blatant disregard for Syrian sovereignty and reiterated Pakistan's support for a Syrian-led and Syrian-owned political process.





Berlin: Germany is set to terminate its fast-track citizenship program, a policy that allowed eligible immigrants to obtain citizenship in just three years.

The decision, reached in an agreement between the Christian

Covert Report Democratic Union (CDU)/ Christian Social Union (CSU) alliance and the Social Democratic Party (SPD), marks a shift in the nation's immigration landscape.

> The Fast-track citizenship program required immigrants to demonstrate

advanced German proficiency (C1level) and strong integration indicators like community service or academic excellence.

Launched by the SPD, Greens, and Free Democratic Party in June last year, the program had been praised by immigrant communities but criticized by right-wing groups, including CDU and CSU. The coalition also ruled out revoking

citizenship from naturalised dual nationals who support extremist ideologies. While this decision may disappoint many, immigrant citizenship Germany remains possible under the five-year citizenship track. This route requires intermediate German proficiency (B1-level) and continuous residency, providing a more achievable path for naturalization. Germany's new coalition government, led

by Chancellor Friedrich Merz, has confirmed that dual nationality will continue to be permitted, along with measures to protect the citizenship of naturalized dual nationals.

However, discussions for Fast-track citizenship program are underway on potential policies to expel individuals who oppose democratic principles, targeting

Sofia: Bulgaria continues its military modernization efforts, now surpassing NATO's 2% defense spending target by dedicating 3% of its GDP to defense, writes Peter Suciu from the National Interest.

The country's latest acquisition, the F -16 Fighting Falcon, marks a significant step in replacing its outdated Soviet-era MiG-29 jets, which had been in service since the late 1980s. In 2019, Bulgaria signed a \$1.2 billion deal with Lockheed Martin for eight F-16s, later increasing the order by an additional eight aircraft in 2021. Due to delays caused by the global pandemic, the first F-16 was expected to be delivered in 2023 but arrived in April 2025.

The delivery of the first F-16 Block 70 is a symbolic moment for Bulgaria, representing its strategic partnership with the United States. Bulgari-

Newswire an Prime Minister Rosen Zhelyazkov described the F-16 as a symbol of this relationship and a new era for Bulgaria's Air Force. The new fighter jets will provide Bulgaria with advanced capabilities, supporting its combat aviation for the next 30 to 40 years, according to Defence Minister Atanas Zapryanov. This modernization aims to boost morale and motivation among military personnel. During the flight from the US to Bulgaria, the new F-16s were accompanied by Slovakian fighter jets. A KC-135 Stratotanker from the Tennessee Air National Guard assisted with mid -air refueling. Bulgaria is now the second NATO member in Europe to receive the F-16 Block 70, following Slovakia, which received its first batch in July of the previous year. Both countries are set to increase their fleets of these advanced jets, with deliveries expected to continue


until 2027. Lockheed Martin currently has 117 outstanding orders for the Block 70/72 version of the F-16, with Taiwan recently receiving its first units and the Philippines approved for future deliveries.

While the acquisition of the F-16 marks a major milestone, Bulgaria's military modernization is far from complete. The country is committed to ongoing upgrades to its armed forces, although Prime Minister Zhelyazkov has dismissed calls for NATO creases premature.

ISLAMABAD: Pakistan's exports to Europe grew by 9.41 percent during the first eight months of the current fiscal year, state-run media reported this week, attributing the surge to rising demand for the country's textile, garments and its GSP Plus status.

The European Union (EU) is Pakistan's

second most important trading partner, accounting for over 14 percent of the country's total trade and absorbing 28 percent of Pakistan's total exports as per official data. Pakistani exports to the EU are dominated mostly by textiles and

arrangement offered by the EU to devel-

oping economies in return for their commitment to implement 27 international conventions on human rights, environmental protection and governance.

"The demand for Pakistani products in Europe has seen a significant rise, leading to a 9.4 percent increase in exports due to Pakistan avails the Generalized Scheme of Preferences (GSP)+ status, a special trade cilitation Council," an official media report said.

It was referring to the SIFC, a hybrid civil

-military government body formed in 2023 to fast-track decisions related to international investment in Pakistan's vital economic sectors.

The SIFC aims to attract investment from Gulf countries, Central Asian states and regional allies in tourism, agriculture, mining and minerals, livestock and other priority sectors.

The state media said Pakistan's exports to Western Europe grew by 11.6 percent and while those to Northern Europe saw a "remarkable" 17.7 percent increase during the first eight months of the current fiscal year.

"The primary reasons behind this growth are Pakistan's GSP+ Status and the rising demand for Pakistani textiles and garments," it added.

The current GSP framework came to an end in December 2023 but Members of EU Parliament (MEPs) voted in October to extend the current rules on the scheme for another four years for developing countries, including Pakistan. Finance Minister Muhammad Aurangzeb has repeatedly stressed the importance of shifting Pakistan's economy from an import-dependent one toward an exportled one, saying that without it sustainable economic growth is difficult to achieve. In recent months, Pakistan has vigorously pursued economic and investment deals with Gulf countries such as Saudi Arabia, the United Arab Emirates and bilateral trade cooperation with Central Asian

# Italy sends 40 rejected as Jum seeks to Alania

Rome: Italy this week transferred 40 migrants whose asylum applications had failed to Italian-run detention centers in Albania.

An Italian navy ship carrying the migrants left from Brindisi in southeast Italy and arrived in the Albanian port of Shengjin.

The migrants, who are all men, are due to remain in a camp in Albania until they are deported.

It is unclear how long they will remain in Albania. Under Italian law, failed asylum seekers can be held for a maximum of 18 months awaiting deportation.

It is the first time a European Union member state has sent migrants whose asylum applications have been rejected to a non-EU nation or to a country that they had not passed through on their journey.

The Italian government, led by the far-right Giorgia Meloni, built the camps as part of a scheme to deter irregular migrants picked up in the Mediterranean from traveling to Italy. But those plans have faced opposition in Italian courts, forcing Meloni to shelve the controversial scheme.

Last month, PM Meloni's right-wing governing coalition decided to instead use the camps in Albania to process asylum applications that have already been turned down.

Irregular migrants would normally be held in detention centers on Italian soil before being deported. The Italian government has not abandoned hopes of enacting its "Albania model," as the European Court of Justice is actively reviewing the case.

PM Meloni's scheme, while controversial, complies with a European Commission proposal which, if passed, would allow member states to open similar "return hubs" to process rejected asylum seekers abroad. Rights groups, including Human Rights Watch, have condemned the EU's proposal as "cruel and unrealistic."





# France may recognise Palestinian state in June

Paris: France plans to recognise a Palestinian state within months and could make the move at a UN conference on settling the conflict in New York in June, President Emmanuel Macron said in an interview broadcast.

"We must move towards recognition, and we will do so in the coming months," Macron, who this week visited Egypt, told the France 5 television channel. "Our aim is to chair this conference with Saudi Arabia in June, where we could finalise this movement of mutual recogni-

tion by several parties," he said.

"I will do it as I believe at some point it will be right and because I also want to participate in a collective dynamic, which must also allow all those who defend Palestine to recognise Israel in turn, which many of them do not do," he added. Nearly 150 countries recognise a Palestinian state. In May 2024, Ireland, Norway and Spain announced recognition, followed by Slovenia next month, in moves partly fuelled by condemnation of Israel's brutal action in Gaza.

Macron said such recognition would allow France "to be clear in our fight against those who deny Israel's right to exist — which is the case with Iran — and to commit ourselves to collective security in the

region."

A formal recognition by Paris would be a major policy shift and risk antagonising Israel and US. France's recognition of Palestinian

France's recognition of Palestinian statehood "would be a step in the right direction in line with safeguarding the rights of Palestinians and the two-state solution," Palestinian state minister for foreign affairs Varsen Shahin said. In Egypt, Macron held summit talks with President Abdel Fattah al-Sisi and Jordan's King Abdullah II and also made clear he was strongly opposed to any displacement or annexation in Gaza and the Israeli-occupied West Bank.

US President Donald Trump has suggested turning Gaza into the "Riviera of the Middle East" with the Palestinians moving elsewhere — a suggestion that has sparked bitter condemnation. Macron responded the Gaza Strip was "not a real estate project". "Simplistic thinking sometimes doesn't help," he added, and, in a message to Trump said "our responsibility is to save lives, restore peace, and negotiate a political framework. If all this doesn't exist, no one will invest. Today, no one will invest a cent in Gaza."
